About the role

At Trust for Nature, our 'product' is a conservation covenant – a legal agreement that protects nature on private property forever, and our 'customers' are people who own land with high conservation value.

Initially reporting to the Nature Markets Manager, this role is essential in driving landholder engagement and delivering self-funded covenant targets. This includes following leads from our regional team, building relationships with landholders, compellingly communicating the benefits of covenanting property to protect nature forever, guiding landowners through the covenant opportunity from enquiry through to an agreement and providing continuous support to facilitate the covenanting process.

Key Responsibilities

The primary responsibilities of the role include:

- Develop a thorough understanding of TFN's business and covenant offerings
- Take inbound calls and respond to email enquiries from landholders
- Follow up on internally generated leads through outbound calls and emails
- Build relationships with and listen to the needs and priorities of landholders
- Clearly and compellingly communicate the benefits of putting a covenant on a property
- Engage with landholders and hold discussions to convert opportunities
- Refer landholders to other people/products within TFN where mutual value can be provided
- Track contacts and interactions using Salesforce and keep informative notes
- Contribute to and maintain the database of landholders who have expressed interest in covenanting their property
- Coordinate the conversion process, including working with other teams to set up agreements, generate invoices, and arrange for regional team members to complete desktop assessments of the property in question
- Provide landholders with regular updates throughout the covenanting process
- Identify and implement process improvements and contribute to the development of procedures and training where appropriate
